This is one of the few occasions when all the Guilds and Liveries come together, and was first held in 1943 as a coordinated response to the challenges faced by the City following the Blitz of 1940-41. The Great Twelve Livery Companies process, and, for the first time the Guild processed with twelve other Liveries/Guilds who follow behind the Great Twelve, on rotation.
